Dear Members,

Recently I sent you an email about our construction progress and the fact that we are coming up short on the budget to complete the project. As I stated, we have secured some private lending from a group of our members to bridge this gap somewhat but we still need to focus on sponsorships to keep us on track and hopefully pay off the debt. After my last correspondence, we did receive an outpouring of support from many of our members with many of them contributing the \$4000 suggested level of support. And, there were several who generously stepped up at levels much higher than that and for that I am very appreciative. I have had a few questions about perks associated with a \$4000 voluntary contribution in lieu of an assessment and I want to reiterate what I previously wrote. The voluntary contribution of \$4000 will help us reach our goal of completion and ultimately help to reduce debt if we can get full buy in. We plan to recognize these members with a special recognition area in the Club and we will likely be organizing a recognition event as well. There are a number of other opportunities that are available and with those higher levels of support may have other incentives attached. If you are not one of the members who jumped in and you are still considering it, we need your support. We had a construction progress meeting this week and we have identified our expected amount to finish at \$750,000 plus some additional furniture and fixtures for the patios, interior, and some additions to our serving ware. We should be on track to open by October or before if we can keep the project moving at the current pace.

Dear Members,

It's hard to believe how far we have come in the last year with the construction of our soon to be new home. See the first picture in this short-cast from June 2024.

With that being said, it has been 2 full years that the board suspended the food & beverage minimums to incentivize the membership to contribute to our construction project, and we wanted to give sufficient notice that effective October 1st 2025 all food & beverage minimums will be re-instated.

What does this mean for you? If your membership dues are renewed November 1st, you will be automatically billed for any unspent minimums from "your" prior membership year. As in the past, your minimums are equal to your dues and you have 1 full year (your membership Year) to meet your minimums, this is not a monthly requirement.

The next page in this short-cast has a sample statement.

In the bottom left corner you will see;

- Minimum Billing Period Nov1/24—Oct 31/25 This represents "your" membership year when your dues automatically renew & reset your minimums
- Unspent Minimum 297.95 This is what you have left to spend on food & beverage only before the end of your membership year.

In this example GM Vincent must spend \$297.95 on food & beverage only, by October 31st 2025 or that amount will be automatically charged on November 1st 2025 billing cycle

• Please keep in mind that this amount is for Food & Beverage only. Tax, service/ gratuity or merchandise do not count towards your minimums.






